CHRISTMAS GIFTS - INFORMATION & GUIDANCE TO THE PUBLIC.

The Jakaranda & Louis Botha Children's Homes' policy regarding receiving Christmas gifts:

The receipt and donation of Christmas gifts should correlate with the purpose, message and GOALS of both Children's Homes. We want to portray the true Christmas message to our children and the public, and make it a real Christian festival. Our primary goal is to normalize Christmas and Christmas gifts to our children by not placing them in the **abnormal** situation where they receive 15-20 gifts each during the holiday season.

The Children's home's policy regarding Christmas gifts:

- ❖ **Every child** in the Children's home may receive a **maximum of two** gifts (such as toys etc.) no more than that.
- ❖ Any **additional gifts** (toys etc.) will be given to our children **at a different stage** (as the opportunity arises) for example birthdays and new admissions to the home.
- ❖ **NO FORMAL HANDING OVER** of Christmas gifts during the festive season, either by companies or groups, will be allowed.
- ❖ If a Company is interested to give gifts we would recommend that they first make contact with our marketing team (info@jacarandachildren.co.za) for a needs list before their gifts collection begins.

Gift guidelines: You are however welcome to **HELP US WITH THE FOLLOWING ITEMS:**

- Toiletries (towels washcloths toothbrushes soap shampoo, personal hygiene products etc.)
- Any Food (Fruit Vegetables Meat etc.)
- Bedding (blankets, duvets, sheets etc.)
- Weekend bags (sports bags)
- Games / Board games or items that can be utilized by the **whole house** (12 children per house).
- School supplies (ie. School bags, stationery, books, etc.)

All gifts will be received by reception/marketing team/storeroom and will then be relocated to the caregivers and children where needed the most. No gifts may be dropped off directly at a house please.
